Students can be any age but must be at least 16 years old to fly solo and over 14 years to log hours.

Cancellations made less than 24 hours before a booking or failure to turn up for a booked flight will be subject to a £50 charge. Payments by bank transfer (BACS) preferred, GFT Ltd 60-09-20 a/c 74725203 (please include name in payment reference), or by debit or credit cards.

Payment Terms

Invoices are sent out monthly and are due for payment by the issue date plus two weeks ("due date"). Non-payment by the due date will result in a temporary no-fly ban. Should the invoice remain outstanding at due date plus a calendar month a penalty – late payment charge – of £100 will be added to the account rendered. Refunds are only made at the directors' discretion and will normally be subject to a surcharge of 20%
